



# LIMITED WARRANTY

## **Simulation Component – Consumable Impact Screen (Front and Back Screen)**

Foresight Sports warrants this product against defects in material or workmanship for the time periods as set forth below. This Limited Warranty does not cover defects caused by any other reason including but not limited to misuse, modification, improper maintenance or assembly, accidental impacts, or acts of God such as lightning strike or natural disasters. Pursuant to the Limited Warranty, Foresight Sports will, at its option, (1) repair the product or (2) replace the product with a new or refurbished product. For purposes of this Limited Warranty, "refurbished," means a product or part that has been returned to its original specifications. No other remedies are offered.

### **PARTS AND LABOR WARRANTY**

For a period of 30 days from the original date of purchase of the product, Foresight Sports will, at its option, repair or replace with new or refurbished product, the product determined to be defective. This warranty will only cover the Impact Screen itself, Front Screen and/or Back Screen. All other components will have their own individual warranty coverage and separate documentation should be consulted for coverage details. All other Impact Screen components are not included under this warranty policy. Warranty does not cover additional Technical or Installation assistance or services for hardware or software. Wear and tear does not constitute grounds to acquire a replacement screen under warranty. All replacements outside of the 30 day warranty coverage will be the responsibility of the consumer. Acceptable coverage may include the provision of a patch-kit, which will be determined by Foresight Sports technicians.

### **WARRANTY SERVICE**

To obtain warranty service, you must deliver the product, freight prepaid, in either its original packaging or packaging providing equivalent protection to the service facility specified. A dated purchase receipt is required. If a component is missing and or damaged upon receipt it must be reported to Foresight Sports within 10 days of receipt of product or may not be replaced under warranty.

### **REPAIR AND REPLACEMENT WARRANTY**

This Limited Warranty shall apply to any repair, replacement part or replacement product for the remainder of the original Limited Warranty period. Any parts or product replaced under this Limited Warranty will become the property of Foresight Sports. Foresight Sports warrants all out-of-warranty repairs and purchased consumables for a period of thirty (30) days. Foresight Sports shall not be liable for any incidental or consequential damages for breach of any express or implied warranty on this product. Except to the extent prohibited by applicable law, any implied warranty of merchantability or fitness for a particular purpose on this product is limited in scope and duration to the terms of this warranty.
